Disclosure of Rate and Contract Term

Fixed Rate. If you have chosen a Fixed plan please refer back to your Welcome Letter for your Fixed Rate and the length of your term. At the end of your Fixed Rate plan, your existing agreement will continue on either: (i) the Fixed Rate plan provided in the renewal notice sent to you between thirty and sixty days prior to the end of your Term; or (ii) on a month-to-month Variable Rate. You may also choose to enroll in a new product offered by Company at the time of your renewal. Cancellation fees as listed on your Welcome Letter or Terms & Conditions will apply if you terminate a fixed price agreement prior to the end of the then-current term.

Variable Rate. If you have chosen a Variable Rate, it will change at the Company's discretion and may be higher or lower each month based on business and market conditions. Variable Rates are set in the Company's discretion and may vary based on numerous factors, including, but not limited to, the Company's assessment of applicable market conditions, operation costs, historic and projected supply and hedging costs, prior meter read cycle's pricing and balancing costs, projected customer bill amounts and Utility pricing or "price to compare" and applicable pricing reset dates and may include the following additional costs: ancillary services and other ISO costs, capacity costs, transmission costs, line loss costs, RMR costs, credit costs, balancing costs, winter reliability costs, and costs associated with meeting any applicable renewable portfolio standards, and a profit margin determined in the Company's discretion that may vary from month to month. Your Variable Rate will not include taxes, which will be assessed separately, and will not include any fees, taxes or charges directly assessed by the Utility or any other third party with the right to assess taxes or fees for the Services.

In addition to Energy Reward's generation charges, you will be responsible for paying the delivery charges as well as any applicable taxes and fees.

Billing

You will continue to receive a single bill from your Distribution Company. Your Distribution Company will set your payment due date and collect payment. Any bill not paid in full by its due date will incur late payment fees set by your Distribution Company. If you do not pay your bill in full, you will receive two requests for payment from Energy Rewards. If your bill remains unpaid, you will be transferred without interruption to standard offer service with your Distribution Company.
